in the Year of our Lord one thousand seven hundred and
seventy nine and in the fourth Year of the Common wealth of
Virginia before me Thomas Reynolds Walker Escheator of the
said County which I have taken by virtue of my Commission
of the said County having returned and examined the
following Persons as jurors to wit. Charles Sayer
Thomas Swell. Jacob Hunter. John Matthias. William
Therogood Junr. Christopher Whitthurst George Jamieson
Henry Collins. William Haynes. James Moore Jr. Henry
Haynes and William Kelling good and lawful men of the
parish of Lynhaven in the said County of Princeps Anne who being
charged and sworn to inquire whether John Saunders was
a British Subject under the Act of Parliament
entitled an Act concerning Escheats and forfeitures from British
Subjects, and likewise to inquire what property real and
personal in the said County of Princeps Anne, belongs at this time
to the said John Saunders, or which did belong to him at the
time the Escheat or forfeitures took place. if he should by them
be denied a British Subject. do say upon their Oath after
hearing evidence that the same John Saunders is a British
Subject under the said Act. by having been an Inhabitant
of the State of Virginia after the nineteenth day of March
One thousand seven hundred and seventy five and before

the Commencement of the Act of General Assembly entitled "an
Act declaring what shall be treason. departing from the said
State, and joining the Subjects of his Britannick Majesty
of his own free Will, and that the following real property does at
this time belong to him being and being in the said County
of Princeps Anne, to wit. a tract of Land whereon he lived
containing about eight hundred Acres be the same or less.
and a Tract of Marsh Land containing four hundred Acres
and that one old Negro man Slave, and one Old Negro Woman
do likewise belong to him, that there were other Slaves and
some Horses which did belong to the said John Saunders.
but this Inquest understands from the Evidence, they were taken
possession of by the Troops of the Common wealth, while stationed
at Fort Mifflin in the said County of Princeps Anne. In
Testimony whereof as well the Escheator as aforesaid as the said
jurors mutually put our Hands and Seals the day and Year
first above written.
