Margent written before I will that all my Debt be paid
and truly contented and paid my will was signed.
Item I Give and Bequeath unto my Son Willoughby Old
One half of the Roted Swamp adjoining the man of Planta-
tion and two Negroes named James & Britton to him and
his heirs forever. Item I Give & Bequeath unto my Son
Thomas Old one Negro Man named Merica to him
and his heirs forever. Item I Give and Bequeath unto
my Son Fredas Old Fifty Acres of Land adjoining
Thompsons swamps line One Negro Man named
Will and One Negro Woman named Nan and all
her increase and One Boy named Young Will and
One Boy named Awa to him and his heirs forever.
Item I Give and Bequeath unto my Son Caleb Old
the Plantation that is in the name of the

her inheritance and One Boy named Young Will and
One Boy named Asatohimian and his heirs forever.
I give and Bequeath unto my Son Caleb Old
the Plantation that I Bought of Thomas Slaghter
and thirty acres of the ^{large part of} Swamp adjoining George
Corporation line also three Negroes named Samuel
& Savor & Argail half Round Swamp adjoining
Cap. Philips line and all the Land I Bought of Josiah
Butt & one boy Mase named Diman and one hand
given to him and his heirs forever. I give and
Bequeath unto my Daughter Lettisha Corporation One
Negro Woman named Martha Shean and her inheritance
and One Negro Man named Peter and fifty acres
Marsh to her and her heirs forever. I give
and Bequeath unto my Daughter Sarah the four
Negroes named Rose, David, China, Euntan and
the Boy named Malachi and one Cedar chest &
all their inheritances to her and her heirs forever. I give
I give and Bequeath unto my Son Edward Old the
man of Plantation that I bought of James Wintrop
containing One Hundred and fifty acres more or
less and fifty acres of Marsh and One Negro girl -

named Dinah she and her increase and Fifty Pounds
back to him as his heirs for ever. I then Give and
Bequeath unto my Daughter Rebecca All the
Land that I bought of William Simmons and One
Negro Girl named Nancy & Negro Man named Tony
to her and her heirs and one half for ever and in
increase my Will and desire is that if my Son Edward
dies before he dies and one or both should die without
lawful heirs that it should be equally divided
amongst the rest of my children. I then Give and
Bequeath unto my two Grandsons William Miller
and Barth M. Miller the man of Plantation that
I bought of Willoughby Miller lying in Norfolk
County to be equally divided between them both to
them and their heirs forever but in case they should
die without lawful heirs my Desire is that it
should be equally divided between the rest of my
children then living. I then Give and Bequeath
unto my Grand Daughter Rebecca Miller One
Negro Woman named Easter and three children
Thomas and China Rachel and all their increase
and in case she should die without lawful heirs
my Will and desire is that the same and all their in-

I the said Rachel and all their heirs
and if case she should die without lawful heirs
my Will and desire is that they and all their heirs
and should be equally divided between the rest
of my children. ~~...~~
I the said I give and Bequeath unto my Son in Law
George Cooper the liberty to cut a ditch twelve
feet wide through my Land down to the head of
a Branch to him and his heirs forever. I the
said I give and Bequeath unto my loving Wife Mary
Old two Negroes one named Jack a Man one Woman
named Sillice to her and her heirs forever, also
the Swamp Land that came by her. Further contain-
ing One Hundred Acres more or less, and as
for all the Remainder part of my Estate of all
kinds and nature whatsoever not already
mentioned after my lawful debts is first fully
paid and my Funeral performed in a Christian
manner I give them all my Estate that is remain-
ing of all kinds I leave to be equally divided between
Richard Old & Caleb Old & Edward Old and my three
Daughters Lettisha Cooper Sarah Jones & Rebecca Old

and I appoint my Son Pedar Old and Caleb Old
 Sole and hole Executors this my last Will and Testament
 Revoking anuling all other Wills and Testaments
 by me formerly made Ratifying and confirming
 this and no other to be my last Will and Testament
 In Witness whereof I do hereunto set my hand
 and Seal this Tenth day of October One Thousand
 Seven Hundred and Seventy Nine
