This Indenture Tripartite made the seventeenth
day of June in the year of our Lord one thousand eight hundred
and one Between Isaac Matthias of the County of Prince
Anne of the first part, Edward Hack Mosley the younger of the
said County of the second part, and Anthony Walke the younge
of the said County of the third part; Whereas the said Isaac
Matthias is justly indebted to the said Edward Hack Mosley
in the sum of One hundred pounds current money of Virginia the
payment of which sum he is desirous to secure and pay to him with
lauful Interest and for that purpose hath agreed to convey the prop
erty herein after described to the said Anthony Walke who is mutu
ally chosen a Trustee by the parties for the purpose herein after
agreed, Now this Indenture Witnesseth that the said
Isaac Matthias in Consideration of the said debt due by him
to the said Edward Hack Mosley and for the further consideration
of the sum of one shilling to him in hand paid by the said Father
Walke at the Execution of these presents the receipt whereof is hereby
acknowledged hath granted, bargained sold aliened and confirmed,
and by these presents doth Grant, bargain, sell, alien, release and
Confirm unto the said Anthony Walke One Plantation tract
or parcel of Land lying and being in the aforesaid County contain
ing by Estimation One hundred Acres be the same more or less and
is the same Land which Reuben Matthias did, deceased in his
last Will and testament to his son Henry Matthias who resided
in the State of New York but at present on a tract in the aforesaid
County who hath lately sold & Conveyed the same to the said Isaac

Matthias and is the same plantation or tract of Land whereto he
the said Reuben Matthias, Henry Matthias son, did, the father of
the said Reuben and Grandfather of the said Isaac & Henry Matto
has resided on at their death as will more fully and at large appear
by the records of the said County register being thence had. To have
and to hold the said plantation or tract of land with all its appur
tenances and improvements therof unto him the said Anthony Walke
his heirs and Assigns forever. Upon Trust, nevertheless that if
the said Isaac Matthias his heirs executors or administrators shall
pay unto the said Edward Hack Mosley his Executors administra
tors or Assigns the said sum of one hundred pounds current money
of Virginia on or before the seventeenth day of June next ensuing 102,
with six per centum Interest thereon to be computed from the date
of these presents till paid, together with the Costs of recovering and recov
ering these presents, that then these presents and every thing herein
contained to cease determined and be utterly void, and that the said Isa
ac Matthias, shall be as fully and completely discharged and entitled
to the said Promises as if these presents had never been made or
Executed, and the said Anthony Walke covenants for himself his
heirs and Assigns to and with the said Edward Hack Mosley
that if the said Isaac Matthias shall fail to pay or cause to
be paid unto the said Edward Hack Mosley his heirs or Assigns
the aforesaid, Debt, interest and Costs on or before the seventeenth
day of June next ensuing, to the said Anthony Walke his heirs
and Assigns upon application of the said Edward Hack Mosley
his executors or Assigns three Weeks notice of the time and place of
