bargained sold aliened released and confirmed and by these presents
doth Grant bargain sell alien release and confirm unto the said
Caleb Boush his heirs and Assigns forever all my right title
and interest of and in my third of the Lands and tenements devised
to me as aforesaid being the Land whereon he lived, and his Bay
side land which is supposed to be, and held for two hundred Acres
more or less, To have and to hold the reversion of, or my right
title and interest of in and to the third part of the Lands and tenements
devised to me by my Uncle the said Thomas Walke being the Land where
on he lived, containing two hundred and fifty Acres more or less being
the third part of the said Tract, and also Sixty six Acres and the third
part of two acres more or less it being my third part of the Reversion of
the Bay-side Land devised to me as aforesaid to him the said Caleb
Boush his heirs and Assigns for ever, to the only proper use and behoof
of him the said Caleb Boush his heirs and Assigns forever, and the

said John Murdaugh the aforesaid tracts or parcels of Land hereby
bargained and sold unto the said Caleb Boush his heirs and Assigns
shall and will Warrant and for ever defend the right and Title of
the same to him the said Caleb Boush his heirs and Assigns forever
against me and my heirs and all and every other person or persons
