

This Indenture made the fourteenth day of December in the year of our Lord Eighteen hundred and one, Between John Thorowgood Senr, of the County of Princeps Anne in the Commonwealth of Virginia of the one part, and William Hunter an Infant under the age of twenty one years Orphan of John Hunter late of said County deceased of the other part, Whereas the said John Hunter was in his life time indebted to the said John Thorowgood in the sum of One hundred and Twenty eight pounds four shillings current money of Virginia, and in order to secure the payment of the same did by deed bearing date the twenty second day of December in the year Eighteen hundred, convey to the said John Thorowgood a certain Tract or parcel of Land lying and being in the County of Princeps Anne containing Ninety Acres more or less; as by the said Deed duly proved and recorded in the Court of the said County of Princeps Anne, reference being thereunto had will more fully appear, and whereas the said John Hunter by his last Will and Testament did give and devise the aforesaid Land with its Appurtenances unto his son the said William Hunter, and did direct that his debts should be paid from the Sale of certain Slaves and other property therein mentioned, as by reference to said Will will also appear, And Whereas the Executors of the said John Hunter under the directions of his said Will hath this day paid to the said John Thorowgood the aforesaid debt with the interest thereon, amounting in the whole to the sum of one hundred & seventy eight pounds four shillings current money of Virginia, whereupon the aforesaid Tract or parcel of Land with its appurtenances

hath become exonerated from the payment thereof, Now This Indenture Witnesseth that the said John Thorowgood for and in Consideration of the said sum of One hundred & seventy eight pounds four shillings current Money of Virginia to him in hand paid as aforesaid, at and before the sealing and delivery of these presents the receipt is hereby acknowledged Hath remise, released and forever discharged and by these presents doth remise, release and forever discharge the said William Hunter his heirs Executors and Administrators (and also the Estate of the said John Hunter deceased) of and from all and every claim and demand whatsoever for or on account of the aforesaid Debt and interest, and of and from all and every claim and demand in Trust or otherwise to the aforesaid Land with its appurtenances, In Witness whereof the said John Thorowgood hath hereunto set his hand and Seal the day and first herein written
