wife by their certain Indenture of bargain and sale bearing date the 2^d
day of September 1801 have sold and conveyed to David Patterson
the full simple Estate of and in certain Tract piece or parcel of Land lying
and being in the County of Princeps Anne containing by estimation one
hundred Acres, and whereas the said Susanna cannot conveniently
travel to our Court of our County of Princeps Anne to make acknow-
ledgment of the said Conveyance, Therefore we do give unto you, or any two
or more of you power to receive the acknowledgment of the said conveyance
which the said Susanna shall be willing to make before you, which witness
annexed, and we do therefore command you that you do personally go
to the said Susanna and examine her privily and apart from her
said Husband whether she doth the same freely and voluntarily without
the threats or persuasions of her said Husband, and whether she is
willing the same should be Recorded in the Court of the said County
of Princeps Anne, and when you have received her acknowledgment
and examined as aforesaid that you distinctly certify us thereof in
our Court of our said County Princeps Anne under your seals sending
them and then the said Indenture of bargain & sale and this writ *Writ*
