This Indenture made the tenth day of August in the year of our Lord one thousand eight hundred and two Between John Woodland sen and Dority Woodland his wife and John Woodland Jun and Mary Woodland of the County of Princeps Anne and state of Virginia of the one part and Robert Land of the County and State of Virginia aforesaid of the other part, Witnesseth that for and in the consideration of the sum of five hundred and fifty Dollars in hand paid by the said Robert Land to the said John Woodland sen, and Dority his wife and John Woodland Jun and Mary Woodland the receipt whereof thers hereby acknow

and therefore doth acquit and discharge the said Robert Land and his heirs and have granted bargained, sold and delivered and by these presents do grant bargain sell and deliver unto the said Robert Land and his heirs a certain tract or parcel of land containing forty six Acres lying in Princeps Anne County and bounded as follows beginning at a maple a corner tree standing in the branch running south to a holly a corner tree thence running west to a birch a corner tree thence running north to a pine a corner tree thence running east to the first station to have and to hold the said tract and parcel of land to the said Robert Land and his heirs and assigns forever with all its appurtenances hereunto belonging or in any wise appertaining to the only proper use and behoof him the said Robert Land his heirs and assigns forever and we the said John Woodland sen, and Dority his wife and John Woodland Jun and Mary Woodland doth for themselves and their heirs warrant and forever defend the said tract and parcel of land unto the said Robert Land and his heirs and assigns forever against them selves the said John Woodland sen and Dority his wife and John Woodland Jun and Mary Woodland and their heirs and all persons or persons whatsoever, In Witness whereof we the said John Woodland sen, and Dority his wife and John Woodland Jun and Mary Woodland hath hereunto set our hands and seals the day and year above written
