This Indenture made the seventeenth day of March in the year
of our Lord one thousand eight hundred and two Between Charles Bradley
of the County of Currituck and State of North Carolina of the one part and
William Searcy of the County of Prince Anne in Virginia of the other part
Witnesseth that for and in consideration of the sum of five pounds lawful
money of Virginia in hand paid, to the said Charles Bradley, by the said William
Searcy at or before the sealing and delivery of these presents the receipt whereof
he doth hereby acknowledge he the said Charles Bradley have granted bargained
and sold and confirmed and by these presents have granted bargained and
sold unto the said William Searcy and his heirs one certain tract or parcel of land
containing three four Acres to the same more or less lying and being in the County
of Prince Anne near the provincial line and bounded by the following courses
that is to say Beginning at a corner holly standing in the line of Co^s Josiah
Butler, and running southerly along, & line to a beech from thence turning
westerly to a beech standing in the Merchants line thence southerly along the
said Merchants line to a white Oak thence easterly down Co^s Josiah Butlers
line to the first stationer holly and all Houses building ways waters water
courses profits and appurtenances whatsoever to the said premises belonging or in any
wise appertaining and the reversion and reversions remainder and remainders
issues and profits thereof and all and the estate right and title of him the said
Bradley of or unto the same, to have and to hold all and singular the
premises thereby bargained and sold with the appurtenances unto the said William
Searcy his heirs and assigns to the only proper use and behoof of him the said
