This Indenture, made the fourth day of April in the year one thousand  
eight hundred and three and in the year of the Commonwealth Between  
Dennis Dowley and Elizabeth his wife of the County of Charles in the  
State of Virginia, of the one part, and David Mithado and Mary Mithado  
his mother of the County of Prince Anne in the State aforesaid of the other  
part, witnesseth, that the said Dennis Dowley and Elizabeth his wife  
for and in consideration of the sum of sixteen thousand six hundred and  
sixty six dollars & 76/100 of lawful money of this Commonwealth, to them in hand  
paid, by the said David Mithado and Mary Mithado at or before the en-  
ding and delivery of these presents, the receipt whereof is hereby acknowledged,  
hath bargained and sold, and by these presents doth grant bargain and  
sell unto the said David Mithado and Mary Mithado their heirs and  
assigns, a certain tract of land situate lying and being in the aforesaid  
County of Prince Anne and bounded as follows to wit, Beginning at a  
Stake, in a Marsh, at a corner of the line of the land, late the property  
of the Rev. Robt Dixon and thence running westerly, binding on the  
same, on a line of marked trees to Anthony Matthes land, thence binding  
on said Matthe to a branch of Gynkawen river, thence binding on the said  
River, the various courses thereof to the first Station, containing Six Hundred  
Acres, to the same now or left, and is the same land which the said  
Dennis Dowley purchased from W. White acting Esq<sup>r</sup> of Newell  
and as will appear & record in Court of the County of Prince Anne the  
day bearing date the 26<sup>th</sup> day of March 1790, with the exception of thirty  
four acres of land in the old Orchard, for a Gravel yard as is expressed

in the deed from the s<sup>r</sup> W<sup>r</sup> White to the s<sup>r</sup> Dennis Dowley together with  
all the singular Houses, dw<sup>r</sup> houses, Barns, buildings, Stables, yards, Green-  
houses, lands, tenements, meadows, pastures, feedings, commonways  
and unwooded ways, waters, watercourses, fishings, privileges, profits, easements  
commodities, advanctates, emoluments, hereditaments, and appurtenances  
whatsoever to the said David Mithado and Mary Mithado belonging or  
appertaining, or with the same used or enjoyed, or accepted, reputed take  
or known, as part, parcel, or number thereof or as belonging to the same or  
any part thereof, and the revision and reversion, remainder and re-  
mainer, yearly and other rents, issues and profits thereof, and of every pa-  
and parcel thereof. To have and to hold the said tract of Land  
with the incumbrances, hereditaments, and all and singular other the pro-  
perty herein before mentioned or intended to be bargained and sold,  
and every part and parcel thereof, with all of its rights, members and  
appurtenances, unto the said David Mithado and Mary Mithado  
their heirs and assigns forever, to and for the only proper use and behoof  
thim the said David Mithado and Mary Mithado their heirs and assign  
power, and the said Dennis Dowley and Elizabeth his wife for themselves  
and their heirs the said tract of land with all and singular the premises  
and appurtenances before mentioned, unto the said David Mithado and Ma-  
ry Mithado their heirs and assigns, free from the claim or claims of  
them the said Dennis Dowley and Elizabeth his wife or either of  
them their Heirs, and of all and every person or persons whatsoever
