This Indenture made the 3<sup>rd</sup> day of September in the year of  
our Lord one thousand eight hundred & two Between Joshua Wright of  
Dennis Anne County, State of Virginia of the one part, and Jesse Morris  
of the same place of the other part, Witnesseth, that the said Joshua  
Wright in order to secure the payment of fifty six dollars & eighty cents  
and in consideration of the sum of one dollar to him in hand paid by

the said Jesse Morris at or before the enclosing and delivery of these presents  
the receipt whereof is hereby acknowledged he the said Joshua Wright hath  
Granted bargained and sold and by these presents doth grant bargain  
and sell unto the said Jesse Morris one parcel or piece of land containing  
Thirty Acs and being and lying in the County aforesaid, and being on the  
land of the said Jesse Morris Solomon Wright dec<sup>d</sup> & William Morris son of said  
and the overseer and overseers remainder and remainders yearly and other  
rents issues and profits thereof and of any part and parcel thereof and also  
all the estate right title interest trust property claim and demand what  
ever both at law and in equity of him, the said Joshua Wright in, to or out of  
the said lands tenements hereditaments and possessions, To have and  
to hold the said lands herein before mentioned to be hereby granted with their  
and every of their appurtenances unto the said Jesse Morris his heirs executors admin-  
istrators and Assigns forever upon trust notwithstanding that the said Jesse Morris  
shall as soon as conveniently he can after having advertised the time and place  
of the said of the property before mentioned giving ten days notice to the said  
Joshua Wright proceed to sell the same to the highest bidder for the best  
price that can be obtained in ready cash and out of the moneys arising from  
the sale, in the first place to pay and satisfy all reasonable charges attending  
the transactions of this business and then the debt above mentioned with in-  
terest thereon, and residue of the moneys arising from such sale aforesaid to the  
use of the said Joshua Wright his heirs executors administrators or assigns or to such  
person as he by writing under his hand shall appoint. In Witness whereof
