 one thousand eight hundred Six Believers Jacomina Whitehurst sur-
 viving Executrix of Joshua Whitehurst dec^d, of the County of Cursons Anne
 and Commonwealth of Virginia of the one part and Jacomina Whitehurst
 James Leahy Adm^r on the estate of Dan^l Murden dec^d and James Leahy
 of the same County and Commonwealth, aforesaid of the other part witness
 full that the said Jacomina Whitehurst surviving Ex^r of Joshua White-
 hurst dec^d, for and in consideration of the sum of twenty dollars by them the
 said Jacomina Whitehurst James Leahy Adm^r on the estate of Dan^l Murden
 dec^d and James Leahy to her the said Jacomina Whitehurst surviving Ex^r of
 Joshua Whitehurst dec^d, in hand paid at and before the sealing and delivery
 of these presents the receipt whereof she doth hereby acknowledge and that
 of she doth hereby acquit and discharge the said Jacomina Whitehurst
 James Leahy Adm^r on the estate of Dan^l Murden dec^d and James Leahy
 and their heirs forever have granted bargained sold aliened transferred
 and conveyed and by these presents do grant bargain sell alien transfer
 and convey unto the said Jacomina Whitehurst James Leahy Adm^r on
 the estate of Dan^l Murden dec^d and James Leahy a piece or parcel of land

situated lying and being in West Neck and known by the name of the
 woods in said County bounding on the land of William Walker dec^d, on
 the north, on James Munden east on William Wests a piece or parcel of the
 north more south and on William Greens land west containing one
 hundred & twenty Acres more or less and all houses buildings out-
 ways watercourses profits commodities hereditaments and appurtenances
 aforesaid thereto belonging or any way whatsoever, To have and to hold
 the said one hundred and twenty Acres be it more or less with the appur-
 tenances as aforesaid, fully bargained and sold to the said Jacomina
 Whitehurst James Leahy Adm^r on the estate of Dan^l Murden dec^d &
 James Leahy and their heirs forever and the said Jacomina Whitehurst
 surviving, Ex^r of Joshua Whitehurst dec^d, doth hereby for herself her heirs
 Ex^r and Adm^r, forever warrant and defend the title of the said bargain
 promises to the said Jacomina Whitehurst James Leahy Adm^r on the
 estate of Dan^l Murden dec^d and James Leahy and their heirs forever.
 To have and to hold the said one hundred & twenty Acres of Land
 as tenants in common with liberty to the survivor at any time to make
 sale of said land and divide the net proceeds of such sale in their
 equal parts to the legal heirs Ex^r Adm^r, or assigns of the parties aforesaid
