This Indenture made the twelfth day of December in the year
of our Lord Eighteen hundred, Between William White and Elizab-
eth his wife of the County of Prince's Anne in the Commonwealth of
Virginia of the one part, and Thomas Stone of said County and Common-
wealth of the other part, Whereas the said William White by Deed
bearing date the thirtieth day of August in the Year of our Lord One thou-
sand seven hundred and ninety eight, did convey in trust to James Taylor
junr, a certain tract of Land situate lying and being in the County of
Prince's Anne containing One hundred and seventy eight Acres adjoin-
ing the Lands of Anthony Walker and Charles Williamson for the pur-
pose of securing and paying the sum of four hundred and sixty five pounds
eight shillings and eight pence to Thomas Newton and James Taylor
Administrators of the Estate of Robert Tucker deceased, as by the said
Deed duly proved and recorded in the Court of s^t County before being
thenceunto had will more fully appear. And Whereas the said James
Taylor junr, by Virtue of the aforesaid deed, and of the Trust thereby reposed
in him did on the first day of this instant December sell and dispose
of the aforesaid Land with its Appurtenances unto the said Thomas Stone
at the Price of five hundred pounds. Now This Indenture
Witnesseth, that the said William White and Elizabeth his wife for
and in Consideration of the sum of the Premises, and also for and in
Consideration of the sum of one dollar to them in hand paid by the said
Thomas Stone at and before the sealing and delivery of these presents the
receipt whereof is hereby acknowledged; Have received, released and forever
quitclaimed and by these presents do remise, release and forever quitclaim,
unto the said Thomas Stone his heirs and Assigns forever All the Estate
right, title and Interest of them the said William White and Elizabeth
his wife, of in and to the said Tract of Land with its appurtenances, And do
for themselves and their heirs hereby ratify and confirm the sale of the said Land

made by the said James Taylor junr, as aforesaid; and the Conveyance though
also this Day made by the s^t James Taylor to him the said Thomas Stone
and his heirs, as fully to all intents and purposes as if the s^t Sale Conveyance
had been made by them the said William White and Elizabeth his wife.
