This Indenture made the Ninth day of February
in the year of our Lord One thousand eight hundred and one
Between Isaac Singleton of the County of Prince Anne
and Commonwealth of Virginia of the one part, and Charles
Fisher of said County and Commonwealth of the other part
Witnesseth that the said Isaac Singleton for and in considera-
tion of the Rent and covenants herein after mentioned, on
the part and behalf of the said Charles Fisher, his Executors, Ad-
ministrators and Assigns to be paid, done and performed, hath
demised, leased and to farm let, and by these presents doth demise,
lease and to farm let unto the said Charles Fisher his executors,
Administrators and Assigns all the Land with the Dwelling
House, Kitchens, Store and all other Houses thereon in the Town
of Kempsville belonging to him the s^r Isaac Singleton To have
and to hold the said Land, Houses, and other Appurtenances
as situate aforesaid unto the said Charles Fisher his Executors
Administrators and Assigns from the first day of January last
for and during, and unto the full end and term of Six years fully
to be complete and ended, yielding and paying therefore the sum
at Rent of Ninety pounds at Quarterly payments, that is to say,
the sum of Twenty two pounds ten shillings at the end of each
and every quarter of a year during the aforesaid Term to be compu-
tated from the s^r. First day of January last past; and the said Charles
Fisher for himself, his heirs, Executors and Administrators doth
 covenant promise and agree to and with the said Isaac Singleton
his Executors, Administrators or Assigns, that he the s^r Charles
Fisher his Executors Administrators or Assigns will well and truly

pay or cause to be paid unto the said Isaac Singleton his Exec-
utors Administrators or Assigns the said annual Rent of
Ninety pounds, in Quarterly payments as herein before men-
tioned, and will also keep or cause to be kept in good and tenantable
order and repair the Houses and other Improvements said Land
and will at the end ^{and} expiration of the aforesaid Term of Six
years, quietly and peacefully yield and deliver in good and tenant-
able order and repair the aforesaid Land with the houses and other
appurtenances unto the s^r Isaac Singleton his heirs Executors
Administrators or Assigns, And the said Charles Fisher doth
also for himself his heirs, Executors, Administrators and Assigns
further covenant and agree that if one yearrent shall remain due
and unpaid at any one time during the aforesaid term of six years
that then and in that case it shall and may be lawful for the
Isaac Singleton his heirs Executors Administrators or Assigns to
enter occupy and possess the aforesaid Land, Houses and other
appurtenances as fully to all intents, and purposes as if these
presents had not been entered into, and the said Isaac Singleton
for himself his heirs Executors, administrators and Assigns doth
covenant and agree with the said Charles Fisher that upon the sum
being punctually paid aforesaid, and the other covenants being
performed by the s^r Charles Fisher; that it shall and may be
