I Give and Dispose thereof in the following manner and manner, I Give and bequeath unto
my Loving Wife Sarah Langley The Use and Labour of my two Negro Men Slaves, to
Wille James and John, during her Natural Life, as also of my Negroes by Name Lavinia
Moll Negro Girl Doll, and a Negro Boy called Wm, and also the Decree my Wife Desire
is for the Give and bequeath the said Negro Slaves abovementioned, with their Increase to
be equally divided between my two Daughters Anna and her Wife of Doctor George Rousseau
and Francis Langley Share and Share alike to them and their Heirs for ever. Item
I Give and bequeath unto my said Daughter Anna Rousseau my Plantation which I purchased
of George Collins, as specified within the Deeds of Conveyance for the Same, I likewise Give and
bequeath unto my said Daughter Anna my Manor Plantation, whereon I now live, with all and
singular the Privileges and Appurtenances, to the same belonging, in any way appertain
ing to her and her Heirs for ever. Reserving the Use thereof to myself, my Loving Wife Sarah Langley
during her Natural Life, as also I Give unto my Daughter Anna, my Tract or Plantation
called Borene, being in Quantity One hundred Acres more or less, all and each of which
said Tracts, parcels and Plantations of Land, to be to the full Use and Dispose of the
Absolute property and Estate of my said Daughter Anna, and her Heirs for ever. Item I
Give and bequeath unto my said Daughter Anna the following, Negro Slaves, to wit
One, Negro Woman called Fennah, Charles, Ned, Anderson, Edw, Abby, Henry, and
Brady with their Increase to her and her Heirs for ever. Item I Give and bequeath unto
my Daughter Francis Langley, my Tract piece of Plantations of Land, hereafter mentioned
to wit, all that Tract or Plantation of Land which I purchased of W^m. I Give also the Tract or
Plantation of Land I Bought of Charles Griffin with all and singular the Privileges & Ap-
purtenances to each respective Tract or Plantation of Land, belonging or in any way appertain-
ing to her and Heirs for ever. As also one Lot of Land Lying and being in New Town
Princess Anne County to her & her Heirs for ever. I Also Give & bequeath unto my said Da-
ughter Francis Langley the following Negro Slaves by Name to wit, Judy, Peggy, Gussy
Lavinia, Mingo, Mowbray, Affricah, Munch with their Increase to her and her Heirs for ever.
as also two Silver Spoons with the Stems and Long and And bid and furniture to her &
Heirs for ever. I Give unto my Son in Law Doct^r George Rousseau, My Silver Watch & Chain
band, to him and at his Dispose for ever. Item my Will and Desire is that my Lands &
Manors not herein before mentioned be equally Divided between my two Daughters Anna and
Francis to them and their Heirs for ever. And that all my Personal Estate of what so ever kind
or Quality & where so ever to be found, within within Doors or without, not herein before mentioned
and Item, or specifically with away, I Give and bequeath to be Equally Divided Between
Amongst my Loving Wife Sarah Langley, and my said two Daughters Anna & Francis
Share and Share alike, My, or my Executors having first paid thereunto my just Debts and
Funeral Expences And further I will Direct and Desire that no Inventory or Apprais-
ment of my Estate be taken into Court, nor any Sale or Outcry be made thereof Except it be
to use publicly and to the highest bidders Such part of my said Personal Estate not speci-
cally given away as aforesaid as shall be thought Necessary and most convenient by my
Executors, and as will be sufficient to Satisfy my said just Debts and Funeral Expences as
aforesaid And Lastly I do Nominate and Appoint my Loving Wife Sarah Langley my whole
and sole Executor of this my Last Will and Testament, Disannulling and making Null and
Void all former and other Wills by me heretofore made & this to be my Last Will and Testament
