to gotten in law I give & bequeath unto my son Thomas my horse Currago, I give &
bequeath to my young black man to my daughter Ann also my negro Sarah I give &
bequeath to my daughter Sarah my negro Jack also ten pounds to be raised out of my
estate for my daughter Sarah. I give & bequeath unto daughter mary one brace
I give & bequeath to my son Thomas one hand mill & one Cupbord. I give & bequeath
my daughter mary my horse Chamption I give & bequeath to my daughter Sarah the
bed in my house. I give & bequeath to my son Thomas one good father bed with the
two. I give & bequeath to my daughter Sarah two Cows & Calves. I give & bequeath to
daughter mary one bed: all & every part of my house hold stuff that is not already given
do divide & order to be equally Divided amongst my Children. I give & bequeath to
Thomas Cloath that I bought to make my self Cloath also my pistols & holsters
their furnitures. I do make & appoint my son Thomas Cochroft whole sole Executor
this my last will & Testament. I do divide & appoint my two loving friends Nath. Hutchins
& John Harper to make the Division of my house hold stuff amongst my Children
unto I have hereunto set my hand & fixed my seals this 24. of November 1728
