Fillis and her increase heareafter. Item. I gave and bequeath to my loveing Brother Jonathan Mackie and his Heirs forever, one Negrow named Nan and all her increase heareafter, and my Watch, I gave and bequath to my Sister Elizabeth Mackie and her Heirs for-ever. Negrow Mary and all her increase heareafter and my Mare cal'd Venus, I gave and bequath to my Sister Anne Mackie and her Heirs forever. Negrow Isbell and her increes heareafter and my black Mare. I gave and bequath unto my brother Thomas Mackie and his Heirs forever one Negrow man called Roger and then the Remainder of my Estate consisting of Cattle Sheep and Hogs, I leave to be eaqually divided between all my Brothers and Sisters then liveing, whareunto I have set my Hand and Seal this Thirteenth Day of April 1795.
