This Indenture made the thirtieth Day of August in the Year of our Lord One thousand Seven hundred and Ninety two, Between Duncan Campbell Mariner, son of Captain Duncan Campbell dec. of the one part, and William Nimmo of the County of Prince George and Commonwealth of Virginia, of the other part, Witnesseth, that the said Duncan Campbell for and in Consideration of the sum of One hundred and Sixty Pounds Current Money of Virginia, by the said William Nimmo to the said Duncan Campbell in hand paid, at and before the sealing and delivery of these Presents, the Receipt whereof, he doth hereby acknowledge, and thereof, and of every part thereof, he doth hereby release, exonerate and discharge, the said William Nimmo his Heirs, Executors and Administrators, hath granted, bargained, sold, aliened, transferred and confirmed, and by these presents doth grant bargain sell, alien, transfer and confirm, unto the said William Nimmo, all that Lot or half Acre of Land, situate, lying and being in the Town of Hempstead, in said County of Prince George whereon the said William Nimmo now lives, and bounded as follows, to wit, Beginning at Capt. Samuel Denmarks Corner Stone, by the main Street or Road and running South two degrees Eastwardly, two hundred and twenty five feet to a Corner Stone, thence North eighty eight degrees Eastwardly, Ninety two feet and one quarter of a foot to another Stone, thence North two degrees Westwardly, two hundred and forty six feet, to another Corner Stone by the main Street or Road, thence along the said Main Street or Road, South twenty four degrees Westwardly
