brook Thoroughgood Daughter of Susanah Thoroughgood my negro girl Sarah, also Lamb to her & her heirs for
Ever only Except of Labour of my said negro to my daughter Susanah during of Childs minority It
I give unto Susanah Thoroughgood three Cows & Calves to her & her heirs for Ever in full for her part or
share of my Estate: It I give & bequeath unto Margret Clowd (my daughter) my negroes Peter, Jo-
sey, Tom, Kate, & all their increases to her & her heirs for Ever: It I give unto Margret Clowd twelve
Dishes twelve plates & six basons all now powder to her & her heirs for Ever: It I give unto Margret
Clowd six Cows & yearlings & two mares (being of James mares given her before) to her & her heirs for
Ever: It I give unto Margret Clowd two Trunks & all my wearing cloaths to her & her heirs for Ever
It I give unto Cason Moor Son of Cason Moor a negro girl called Nanny & negro boy called Tony
to him & his heirs for Ever: It I give unto Henry Moor Son of Henry Moor my Son two negroes
named Jacob & Betty to him my said grand-Son & his heirs for Ever: It I give unto my Son Cason
moor one silver Tankard to him & his heirs for Ever. I give all my real Estate that is negroes not
already given to be Equally divided between my Sons Cason & Henry Moor to them & their heirs for
Ever: It I give & bequeath all of remaining part of my Estate of what nature or property soever
to be Equally divided between my two Sons Cason & Henry Moor & my daughter Margret Clowd to be
Equally divided between them three to them & their heirs for Ever: Lastly I do make & ordain Const-
able & appoint my Sons Cason & Henry Moor & my Joint Ex: of this my last will & Testament to see &
perform Every Clause herein Contained according to my true Intent & meaning In witness and
Confirmation of every thing herein mentioned I have hereunto set my hand & Seal this 6th
Day of April in 4 years 1719
