I give and bequeath to my beloved son James &

Executrix and my beloved friend John Wright gent. & &
Executor of this my last Will and Testament Revoking
and disanuling all former wills by me made Confirm-
ing this to be my last will and Testament; I N^d
Witness whereof I have set my hand Seal this 30th &
day of January 1743/4
