any of any of my Negroes not before in this my Will given and disposed off as they may think proper
and the money arising from the Sale thereof to be applied towards the payment of my Just Debts &
the balance if any to be equally divided between my five brothers John, William, Colston, Lyndon
& Benjamin Smith & my three Sisters, Susanna, Elizabeth, & Moriah Smith as they arrive to the
Age of twenty One years

I then My lands and plantations and all the rest of my Estate of Whatkind soever I desire may
be Equally divided between my said Brothers & Sisters (which I desire my Executors may help
possession off) and as they arrive to the Age of twenty One years &c

Item, It is my Will & desire that my Executors hereafter named may have the liberty of disposing of any of my Negroes not before in this my Will given and disposed off as they may think proper and the money arising from the Sale thereof to be applied towards the payment of my Just Debts & the balance if any to be equally divided between my five brothers, John, William, Colston, Sydney & Benjamin Smith & my three Sisters, Susanna, Elizabeth & Sarah Smith as they arrive to the Age of twenty One years.

Item: My lands and plantations and all the rest of my Estate of Whatkind soever I desire may be Equally divided between my said Brothers & Sisters (which I desire my Executors may keep possession off) and as they arrive to the Age of twenty One years to receive their proportionable part of the Same, and the profits arising therefrom to be applied towards their Support and Maintenance or either of them as my Executors may think proper.

And lastly I do hereby Appoint my friends Brothers: M^{rs} Bay, Ezekiel Long & John Sydney Executors of this my last Will & Testaments in Witness whereof I have hereunto set my hand & Seal this 3rd day of August 1792
