

In the name of God Amen. I, Rodham Pritchard of the County of Richmond do make & declare this present writing to be my last will & Testament in manner and form as followeth. Wt.

Item. I give and bequeath unto my daughter Nancy Smith my Negro Woman named Hannah to her & her heirs forever.

Item. I give and bequeath unto my granddaughter Peggy Timmon Smith my Negro Boy Mary to her & her heirs forever.

Item. I give & bequeath unto my Grandson Samuel Smith my Negro Boy Bill to him and his heirs forever.

Item. I give and bequeath unto my Grandson Gabriel Smith Pritchard my Negro Girl Frank to him & his heirs forever and if he should die without heirs to return to his Survivors.

Item. I give and bequeath unto my Granddaughter Nancy Garner Pritchard my Negro Boy little James to her and her heirs forever & for the want of such heirs to return to her Survivors.

I give unto the two last mentioned Children Gabriel S. Pritchard, & Nancy G. Pritchard two Acres & a half (One to each of them) also One Thousand

I give unto the two last mentioned Children Gabriel S. Patchet, & Nancy G. Patchet two Hens & Goats (One to each of them) also One Thousand Pounds of Virgin Tobacco to be applyd to the use of the said two Childrens Schooling.

Item I give and bequeath unto my loving Wife Justice Patchet all the remaining part of my Estate both real & personal during her natural life, or widowhood, and provided she should marry then my Will is that she have her choice of the best two Negroes in my Estate and she (my said Wife) to dispose of them at her death at her own Option.

I Item I give (after my said Wifes decease) all my Lands, to be equally divided betwixt my two Sons Rodham and John to them & their heirs forever.

Item I also give unto my Son Samuel Conaway (after my Wifes decease) my Negroe Modest Mell. & Boy Harry and all their increase (in future) to him & his heirs forever.

All the residue of my Estate (Excepting the Legacies before mentioned) I give (after my wifes decease) to be equally divided betwixt my Children, namely Rodham, John, Samuel Conaway, Susanna and Polly. I do constitute

my two sons Rodham and John to them & their heirs forever.
Item I also give unto my Son Samuel Conaway (after my Wifes decease) my Negro
Rodham M^{ll}. to my Son Harry and all their increase (in future) to him & his
heirs forever.

All the residue of my Estate (excepting the Legacies before mentioned) I give
(after my wifes decease) to be equally divided between my Children, namely
Rodham, John, Samuel Conaway, Susanna and Polly. I do constitute
and appoint my Friends Capt Thomas Williams, Thaddeus Williams,
and Thomas Coleman to be Executors of this my last Will & Testa-
ment In witness I have set my hand & Seale this 15th of November
1790

my Negro man Adam should be hired out for the use of my Wife Judy
Pritchett as long as she lives, should she choose it.

At a Court held for Richmond County the 4th day of July 1791
This Will of Rodham Pritchett deceased was proved in Court by the Oath
of two of the Witnesses thereto and admitted to Record and the Executors thereunto
named having refused to Qualify no Person appearing to take Administration
with the said Will annexed. It is therefore ordered that the Sheriff take the Estate
into his hands and Administer the same according to Laws that he make
Sale thereof upon Six Months Credit. the widow of the said Pritchett came
into Court and assented to the said Will.
