

Alfred Harvey. The State of Ohio

Be it remembered that at a Probate Court held at the Court House in the City of Gallipolis in said County of Gallia, on the 6th day of February A.D. 1878 by H. A. Kent sole Judge of said Court, a paper writing purporting to be the last Will and Testament of Alfred Harvey, late of said County, deceased, was presented for Probate and was partly proved by the oath of James Barton one of the subscribing witnesses to said paper writing, whose testimony was reduced to writing and signed by said attesting witness in open Court, and it appearing to the Court that Jacob Gross Jr the other subscribing(?) to said paper writing is sick and cannot and cannot come into Court. Thereupon, on motion it is ordered that James Barton he and he is hereby appointed Commissioner to take the deposition of the said Jacob Gross Jr, at such time and place as the said Commissioner may appoint, and it is further ordered that a Commission issued to the said James Barton, and it is further ordered that the said Commissioner reduce such examination to writing and return the same together with the Commission, and the will of the said Alfred Harvey, deceased, then annexed, closed up under his seal into our said Court, with all convenient speed; and it is further ordered that this cause stand continued to the 8th day of February A.D. 1878, at 10 o'clock A.M.

And now came James Barton heretofore appointed Commissioner to take the deposition of Jacob Gross Jr, a subscribing witness to the last will and testament of Alfred Harvey deceased, and file a report of the examination of the said Jacob Gross Jr, reduced to writing, and from the evidence the Court find that the said paper writing is truly the last will and testament of the said Alfred Harvey, deceased, and has been fully proven. And the Court further find that the said Testator at the time of executing said will, was of full age, of sound disposing mind and memory, was not under any undue or ill legal restraint and has since departed this life. Thereupon, it is ordered that the said last Will and Testament of the said Alfred Harvey, deceased, be admitted to Probate and the same together with the Proof be recorded. Which said Will is in the words and figures as follows:

In the name of the Merciful Father of all, I, Alfred Harvey of Addison Township, Gallia County and State of Ohio, do make and declare this to be my last Will and Testament.
Item 1st. It is my will that my just debts and funeral expenses be paid.

Item 2^d. I give and bequeath to Mary Ann Harmon (my niece) one black colt.

Item 3^e. I give and bequeath to Governor F. Harmon (my niece's husband) one bay horse.

Item 4^f. It is my will that the remainder of my property, real and chattel be given to said Mary Ann Harmon and Governor F. Harmon, in equal portions.

In witness whereof I have hereunto set my name this 28th day of Dec. A.D. 1877.

Item 5^g. I hereby revoke all former wills by me made. The said Alfred Harvey signed and acknowledged this as his last Will and Testament, in presence, and we signed it in his presence } Alfred X Harvey mark

At Roanoke County Court, July Term 1882.

A paper writing purporting to be an authenticated copy of the last Will and Testament of Alfred Harvey deceased, and the certificate of probate thereof in the Probate Court of the County of Gallia, in the State of Ohio was this day offered for probate in this State, and it appearing from said certificate that the said Will was duly executed and admitted to probate as the last Will and Testament of the said Alfred Harvey deceased in said County of Gallia and State of Ohio, the same is admitted to probate in this Court.

3rd I give to my wife Matilda Griss, at the time of my death, one third part of the net proceeds of sale in cash of my personal property. Whatever personal property I may have
