

2 Strickler, In the name of God, Amen. I, John Strickler of Salem,
Roanoke County Va., being of sound mind, make this my last
Will and Testament this 24th day of March 1878, as follows.
I leave and bequeath to my dear wife, Mary E. Strickler,
during her natural life all my property both Personal
and Real, and at her death I direct that all of said prop-
erty be equally divided between my sons Joseph, Samuel
& John, & none others, I further direct that my said sons
Joseph, Samuel & John use my chair factory & machinery joint-
ly, and from profits accruing therefrom, or from profits de-
rived from my Peach Orchard or from any other source,
be set aside exclusively for the support of my said wife.

I also direct that my said son Joseph at the death of my
said wife, is to receive Fifty dollars (or its eq^{valent}) more
than my said sons Samuel or John.

It is strictly my request that my said sons stay & work
together and do what they can jointly to pay all debts that
may be against my property as likewise rendering all
assistance necessary to render my said wife comfortable
during her natural life.

I appoint my said wife Mary E. Strickler my lawful
Executrix, if she is not eligible, or declines to act, then
I appoint Henry M. Carst my lawful Executor.

knowing the uncertainty of life, but being of sound mind,
make this my last Will & Testament, as follows.

I leave & bequeath to Robert Thaxton the Eastern Half of
my dwelling house & lot situated on Clay Street of said Town,
now being the part occupied by Mrs Lucy Withier and Thomas
Rhodes. The Western half of my said dwelling house & lot, inclu-
ding one half the pump, well & fixtures, as also water privilege

+ access to same, mahogany bedstead + bedding, roll of new carpeting, cooking stove + utensils, tea set, looking glass, pictures + toys I leave + bequeath to Mary Louisa Glass, reserving the bed room + kitchen adjoining each other in said Western end of said dwelling house, water privileges, + free use of said one half of Western lot, I leave and bequeath to Patsy Taylor during her natural life, as also the use of my safe, half dozen chairs + dishes enough for the use of the said Patsy Taylor during the said time, and after her death, I direct that all articles given to her + privileges revert to the said Mary Louisa Glass. I also direct that my son's picture be given to my cousin John Goldman, + my log cabin quilt, I direct that it be returned to W. Margret Closs of Durham N.C.

I also direct that after reserving the foregoing articles as set forth, that the remainder of my personal property be sold, and as much as may be necessary from the proceeds of said sale, be taken to aid in payment of my debts + funeral expenses, And after said payment, I direct that the remainder of proceeds of said sale, be given for the benefit of the Methodist Episcopal Church south of said Town.

I appoint J. Boon of said Town my Lawful executor to carry out the requirements of this my Will, + require him to give security for the faithful execution of it. As witness my hand + seal this 19th day of April 1880.
