Devill, as well as all monies, notes, or accounts due me, real personal or other assets, which may belong to me at my death, out of which he shall reimburse himself for the said amount of Twenty nine Hundred Dollars given me by him, and shall then pay any balance which may remain to my daughter Jennie S. Devill,

Having full confidence in the ability and integrity of my son Alex S. Baird I appoint him my sole executor.
