I, David Goodwin of Roanoke County, being of sound mind and memory, but infirm in body, and knowing the uncertainty of life and certainty of death, do make and ordain this writing to be my last will and testament, hereby revoking any and all other wills by me heretofore made.

First. I desire, after my death, that all my just debts be paid by my Executor hereinafter named, and after the payment of these, I desire to make the following disposition of my property.

2^d. I give and bequeath unto my beloved wife Catharine O. Goodwin, for and during her natural life, the farm on which I now live, containing about one hundred and fifty acres of land, together with all the buildings and improvements on same, to have and to hold for and during her natural life, and at her death, I devise the said land with all the improvements thereon to my daughter Lucy Jane Goodwin in fee.

3^d. I give and bequeath unto my said beloved wife, all my personal property of every kind and description, to be used held and enjoyed by her, for and during her natural life, and at her death, I give and devise whatever of personal property may be left, including the increase of stock, to my daughter Lucy Jane Goodwin.

This devise to my daughter is made in consideration of the fact that she, my said daughter has remained with me in my old age.

4th. I give and bequeath unto my son Henry B. M. Goodwin my interest in the Joseph Stover tract of land which adjoins my land on the North, and I also desire that my daughter Lucy Jane Goodwin, and the devise to her of the land on which I now live is conditioned upon her doing so, shall convey to said Henry B. M. Goodwin at my death her interest in the said Joseph Stover tract of land, which she has in same under the will of Joseph Stover, or in any other
