Corley have one part - and that the bodily heirs of my daughter Lucy Walden decd. have one part - and the bodily heirs of Eliza Walden decd. have one part - and the bodily heirs of Vandona Wheeler have one part -

And lastly as to all the rest residue and remainder of my goods and chattels of what kind soever I give and bequeath them to my beloved wife Sarah Corley whom I hereby appoint sole Executrix without security of this my last will and Testament; hereby revoking all other wills by me made

Willard; Thirty Dollars to A. W. Fleming; Twenty Dollars to Captain R. E. Lee; Twenty-five Dollars for himself; Two Dollars and Fifty Cents to J. W. Drew; Two Dollars and Fifty Cents to Small, the Florist; I also owe something to J. D. Langhouse, the amount of which can be ascertained from J. Lawrence Campbell, this I desire to be paid; all the residue to be paid to my two sisters, Letitia L. and Alice W. Holcombe, the survivor of them.

In making this disposal of my property I feel that I am acting for the best in giving to those who will need it most. I wish my cousin Edward W. Robertson to act as my Executor, and I request that no security be required of him.
