I Joseph W. Bandy, of the County of Roanoke in the State of Virginia, being of sound mind and disposing memory, and recognizing the uncertainty of life, and the certainty of death, do make this my last will and testament, hereby revoking all all other wills previously made by me.

I direct that my body shall be decently buried and a monument erected over my grave, and enclosed with iron fence. I direct that all debts or demands due or owing to me shall be collected, and that all just debts or demands against me, either heretofore or hereafter contracted, including those incident to my death and burial shall be paid, and the residue of my personal property, if any, shall be paid or transferred to, and become the property of my brother, John C. Bandy, to have and use the same, or the proceeds thereof during his natural life, and after his death, it shall pass to and become the property of Miss Annie L. Kasey.

I also direct that all the lands and tenements of which I may die seized and possessed, shall be transferred to and become the property of my brother, the said John C. Bandy, to have, hold and use the same, and the emoluments thereof during his natural life, and after his death, the said lands shall become the property of the said Miss Annie L. Kasey, but the said John C. Bandy shall have authority, if he so desire, after my death, to sell said lands or any portion thereof, provided the said Miss Annie L. Kasey shall consent to said sale, by joining in a proper deed of conveyance of the same.

If the death of the said Miss Annie L. Kasey shall occur prior to that of the said John C. Bandy, and she leaves no heir of her body living at the time of his death, then all the above provisions for her benefit shall be void, and all of my property, both real and personal shall pass to, and be vested in said John C. Bandy to hold and dispose of as he may deem proper.

Nothing contained herein shall be construed to deprive me of the right, during my life time, to sell or dispose of any or all of my property, either real or personal, in any way I may deem proper.

I hereby appoint and constitute my friend D. C. Kefauver, the executor of this my last will and testament.

I Margaret Aliff - of Roanoke County and State of Virginia, - being old and infirm but of sound and perfect memory and mind and considering the certainty of death, and the uncertainty of the time thereof do make and apoint - this my last will and Testament in the manner and form following to wit - First and principally I commit my soul to God, in simple hopes of its future happiness and my body to the earth to be buried in decent Christian Burial - = = =

I loan to my husband Josiah Aliff all of my lands, and also loan to him all of my personal property for him to have and hold so long as he lives - and after the death of my husband, I give to my daughter Isabella Agee Forty acres of my land lying on the North side of the Road including the house that she now lives in this Forty acres of land is to go to the heirs of my daughter Isabella Agee, after her death - The remainder of my Lands I request to be divided between my son Wesley T. Aliff, and Nancy M. Moul, and to their heirs when they are dead and gone - I request that Wesley T. Aliff shall have his part of the land including the old home home where he now lives in I give to my daughter Augusta Susan Moul - The sum of Three hundred Dollars - I also give to my son Wingfield S. Aliff and his children The sum of Three hundred Dollars - said amount that I give to my daughter Augusta Susan Moul and to Wingfield S. Aliff to be paid by my heirs that get my lands each one of my heirs that gets my lands is to pay an equal share of said Amount that due to said heirs - I charge Augusta Susan Moul with the sum of 200 hundred Dollars, which I have paid her on the Amount I give to her the remaining One hundred Dollars that yet due to her to be paid in Three years after the Division of my lands - I request that Wingfield S. Aliff shall be paid in payments as follows by my heirs that get my lands one hundred Dollars, at the end of one year after the Division of my lands - Also one hundred Dollars, at the end of Two years after said Division - And lastly one hundred Dollars at the end of Three years - after said Division of my lands - I request that after the death of my husband that all of my personal property shall be sold at Public Sale and the Proceeds of the sale to be equally divided amongst All of my heirs - whatever Amount there may be left after all Funeral and Burial expenses is paid - In testimony whereof I have hereunto set my hand and seal this 30th day of October 1893.
