

Julia A. Harlowe.

On the name of God. Amen.

I Julia Ann Harlowe, wife of John M. Harlowe of the town of Salem and State of Virginia, being the owner of a separate estate, and being sound in mind and memory, but in delicate health, do make this my last will and testament.

First. I desire to recognize my Heavenly Father, of whose tender mercies I have received during my entire life, and to express my steadfast hope for salvation, through the Lord Jesus Christ, to whom I commit my body and my soul, and all who are dear to me.

Second. I give to my dear husband, John M. Harlowe, to be held by him for and during his natural life, free from any debts, claims or demands against him, whether heretofore or hereafter contracted, my house & lot on Broad Street in the town of Salem, and at his death, &c. same shall be held jointly by my two daughters or their descendants, and in case of the death of either Bettie M. Harlowe or Olivia J. Harlowe, without issue, I direct that the moiety of my estate, which she or her issue would hold under this will, shall descend to the surviving daughter or her issue.

Third. I also have a certificate of deposit of the Farmer's National Bank of Salem, for \$330, which was from the proceeds of my separate estate in the County of Shenandoah. I desire my executor to settle a balance of \$100. due to Hollins Institute on account of tuition to apply \$100. or so much thereof as may be necessary to the payment of my funeral expenses to pay \$45. to J. M. Evans and other Trustees of the Baptist Church of Salem, to be applied and used for the benefit of the said church, in such manner as the Trustees may deem best. The residue of the said sum, after paying cost of administration, I desire my executor to pay over equally to my two daughters Bettie M. and Olivia J. Harlowe.

Lastly. I appoint my dear husband John M. Harlowe, the executor of this will, and I direct that no appraisement of my estate be had, as the same is specifically stated in this will, and that no security be required of him as such executor.
