The last Will and Testament of Margaret Aliff, deceased, was this day produced in Court and proved according to law by the oaths of Elijah Poage and J. T. Henry, two of the subscribing witnesses thereto, and thereupon ordered to be recorded.

Fishburne I hereby declare this my last will and Testament, I will and bequeath to my two youngest children, Annie B. & William Nevins Fishburne, all my possessions, Real, Mixed and Personal & appoint W. H. Fishburne my Executor, and authorize him to collect any accounts, or bonds, due me, and to sell any Real Estate, I may have, when he thinks best to do so.

I wish he and Annie to take quiet possession of all my other property, & request them to distribute to my other children, the money or property, named in the paper accompanying this, but do not want it recorded, or they have to account to Court or any one, as I know they will carry out my wishes.

Nevins is not to give security, as I know he will do what I wish.

In the County Court of Augusta County, January 23rd. 1894.

This writing, dated May 27th. 1890. purporting to be the last will and Testament of Mrs. Margaret L. Fishburne, dec'd, was produced in Court by W. H. Fishburne, the Executor therein named, and there being no subscribing witnesses thereto, E. E. Wallace was sworn and deposed, that he was well acquainted with the Testatrix hand writing, and verily believes the said hand writing, and the name thereto subscribed, to be wholly written by the Testatrix own hand, who was at the time of sound mind & disposing memory, whereupon the said writing is recorded as the true last will and Testament of the said Margaret L. Fishburne, dec'd. And on the motion of the said W. H. Fishburne, Executor therein named, who made oath according to law, and entered into a bond in the sum of One Hundred Dollars, payable and with condition as prescribed by law, which bond was acknowledged in Court by the obligor thereto, and ordered to be recorded (said bond waiving the Homestead Exemption). Certificate is granted the said W. H. Fishburne for obtaining a probate of said will in

due form. The Testatrix in her said will having requested that no security be required of her Executor in his official bond, for cause appearing satisfactory, none is required by the Court. The estimated Value of Estate, Real and personal passing under said will being \$2500, ordered that said Executor pay the State Tax of \$2.50. cents thereon

1st it is my request that my executor hereinafter named to pay all My Burial & Funeral expense also to pay all doctor bills and all other just debts, that I may owe at the time of my decease

2^d it is my request that my son Noah Roub after the decease of both Myself & My wife, shall have all my land houses & shops - and that he shall pay to his sister Eliza Roub Two hundred doll as her part in the land &c also to pay to Henry Roub his Bro Two hundred doll as his part in the land &c 3^d I give & bequeath to my son Noah Roub all my horses cattle farming utensils & all my shop tools in both shops and all the Machinery &c in the shops 4th it my request that after the decease of both Myself & My wife that all my house hold & Kitchen furniture be equally divided between my two children Eliza & Noah -

5th it is My request that any money or property not heretofore dispose of that I may have at my decease shall be given to my daughter Eliza.

6th I hereby appoint my son Noah Roub as my administrator and request that he give no security
