In the name of God amen I Margaret Ledgerwood of the County of Montgomery State of Virginia, getting old and Infirm and well knowing the uncertainty of this Life and therefore appointed once to die, Therefore make and ordain this my Last will and Testament, that is to say, I Give and Bequeath to my Nephew, William Hall and his wife Nancy Hall, for their kind services shown me, all my Real Estate that I am possessed, with during their natural Lives after their Decease to her the s^t Nancy a Children that she has now or may have, I Give and Bequeath to my grandson David Hall a yearling Sorrel Colt, I give and Bequeath William Ledgerwood my Brother a new suit of Homespun Clothes. If I have any Horse beast in my possession at my death I Give and Bequeath it to

my brother David Ledgerwood, I direct William Hall to pay David Ledgerwood my Brother forty Dollars in property out of my Estate, I Give and Bequeath to Isabella Ledgerwood child, Susan Ann, a Likely Cow, also my Sister Mary, Ledgerwood, is to have paid to her Ten Dollars in property, I Do hereby constitute and appoint my Neighbour Jacob Doosung Junr my Executor of this my last will and Testament Breaking all all other wills and Testaments heretofore by me made in witness whereof I have hereunto set my hand and affix, my seal this twenty seventh Day of September in the year of our Lord one Thousand Eight Hundred and Thirty four

Charles W. Stevens. In the name of God, Amen, I, Charles W. Stevens of Roanoke County Va, being of sound mind and memory, and knowing the certainty of death, and the uncertainty of life, do hereby make this my last will and testament.

In the first place, I direct my Executor, hereafter named, after giving my body a decent, Christian burial, to pay my just debts out of my estate.

2^d After my said debts are paid I direct that the balance of my personal property be divided equally between my wife and two children, 3^d That the land that I own in Bedford County Va, I bequeath to my two children to be sold by my Executor and the proceeds to be divided equally, between them when the youngest one of them is twenty one years old, until that time said lands are to be rented, by said
