Maria Withers In the name of God, Amen.

I Maria Withers of the County of Roanoke, State of Virginia, being of sound mind and disposing memory do make and publish this my last Will & Testament hereby revoking all former wills by me made.

I. After the payment of all my just debts and funeral expenses I devise to my sister Julia A. Withers all my estate both real and personal to be by her held for and during her natural life, except as to any money that may be on hand after the payment of my just debts and funeral expenses - all debts due me or in which I may have an interest, my interest in the stock of goods that may be in the store at my death - the three last mentioned articles I leave to her absolutely to be used and expended by her as she may desire.

II. After the death of my sister Julia, I devise my interest in and to the house and lot situated on Main Street in the Town of Salem in which we now reside and which was devised to us by our father John Withers die'd by his last Will and Testament, to my Brother

Alfred A. Withers and his wife Susan C. Withers for the term of their natural lives and after their deaths then I devise my said interest thereto to the children of my said Brother Alfred and his present wife, the said Susan C. Withers to be owned by them jointly, share and share alike, and in the event of the death of either or any of them before the division of the said property ^{or} them, then it is my will that the survivor or survivors shall have the share or shares of those thus dying, unless those thus dying shall leave heirs of their bodies, then such heirs shall have the share or shares of their parents.

III. After the death of my sister Julia I devise to my niece Laura J. McLavy and my nephew Frank W. McLavy all my interest in and to the lot with all the improvements thereon situated, lying on the Main Street of the Town of Salem West of the Dry Branch adjoining the lot of Dr Montgomery Peter being the lot purchased by my sister Julia and myself from Mrs Susan Shanks. In the event of the death of either of them before the division of the said property hereby bequeathed to them, then the survivor to have the share of the one dying, unless the one dying shall leave heirs of the body then such heirs to have the share of the parent. It is further my will that Arthur McLavy, the father of the said Laura J. and Frank W. shall have a home in the property hereby bequeathed to his children so long as he may live and remain unmarried.

IV. After the death of my sister Julia I devise to my niece Cordelia Belvoir all my interest in the house and lot situated on Market Street in the Town of Salem purchased by my sister Julia and myself from Arthur McLavy.

V. After the death of my sister Julia I devise to my niece Laura J. McLavy all my interest in the furniture of all kinds that may be in the house in which we now reside.

VI. Should my sister Julia, after my death, deem it advisable to dispose of the house and lot described in the III paragraph of this Will devised to Laura J. and Frank W. McLavy, and invest the proceeds thereof in such manner as she may deem best for the use and benefit of my Brother Alfred and his family, she is hereby empowered to do so, and to execute a deed to the purchaser thereof. But in such event such investment shall be in lieu of the provisions made in the II paragraph of this Will and shall go and descend to the same parties and in same manner as provided in said Paragraph II and the house and lot described in said paragraph II shall go and descend to said Laura J. and Frank W. McLavy in the same manner and subject to the same charge as the house and lot so disposed of would have gone but for such disposition.
