Whereupon the said writing is ordered to be recorded as the true last Will and Testament of the said Fannie A. Hawley deceased.

Mrs. Mary B. White.

I, Mary B. White of Fort Lewis, in the County of Roanoke and State of Virginia do make this my last Will and testament.

First I give to my beloved husband Alexander White for and during his natural life all my property both real and personal not herein otherwise disposed of, the same to be held by him for life and not in any event to be subjected to any debts for which he may be now or hereafter liable, I desire that the taxes accruing from year to year be paid first of all out of the products of the farm.

Second. After the death of my said husband I direct that my lands be divided, (by three disinterested commissioners to be appointed by agreement of those of my children to whom I devise the lands) into eight equal parts having reference in such division to quantity and quality, but the dwelling house and other contiguous buildings including the kitchen, office, stable, barn &c. shall not be estimated at all in such valuations.

Third. I direct that of the eight divisions so made, three of them including that one on which the said buildings are situated be assigned to my daughter Fanny Penn which said three divisions so allotted to my said daughter Fanny Penn shall adjoin each other.

Fourth. To my sons Samuel, James Oliver and William Lewis I give one dollar each to be paid to them by my Executor. My daughter Fanny Penn White is at liberty to give to my sons James, Oliver and William Lewis in the manner she may deem best a part of the lands devised to her.

Fifth. To each of my daughters, Mary B. Read, Martha E.

Shanks, J. Helen Shanks, Anna P. White and Lucy N. Beller I give one of the eight divisions of my lands above provided to be made. I direct that the portion of the land which my daughter Martha E. Shanks shall take be held by her to her sole and separate use in fee simple. Except as to the conveyance which I have authorized Fanny Penn to make to two of my sons if she shall see fit to do so. I direct that the lands held by all my daughters be to their sole and separate use vesting in my married daughters only a life estate with the fee simple to their children, such fee simple to vest in the children immediately on the death of the mother, and if either of my children die childless being at the time of the death seized of any of the lands herein devised. I direct that the lands of such decedent descend in fee simple and equally to the surviving children of all of daughters.

Sixth. I give my cows and calves to Fanny Penn, my gold watch to Lucy N. Beller, my writing desk to J. Helen Shanks, my picture of _____ and my Majolica vases to Esper White Shanks, my motto to Maria L. Shanks, my table cloth and one dozen napkins given to me by Mr. Somerville to Martha E. Shanks, to Ann P. White my glass spoon stand, Majolica cream pot and butter dish to Mary B. Read the white counterpane and bureau cover made and given to me by my mother. All other things I have I leave with ^{Fanny Penn with} written instructions as to their disposal.

I appoint _____ the Executor of this will.
