Thirdly, I give to my beloved wife, Mary Armistead Tyler, in testimony of my affection for her all my property, both real and personal to be used by her for her maintenance and support during the remainder of her natural life, she may use both the interest and principal of all my property for her maintenance, should it be necessary.

Fourthly, If my said wife should die leaving any balance of my said estate unused, then I will it in fee to my three children, J. Arthur Tyler, Mrs. J. W. Morgan, and Mrs. W. H. Sangerston, to be divided equally between them.

Fifthly, I make my beloved wife my sole executor under this my last will and testament, and it is my desire that she act without giving security.

The last will and testament of Thomas W. Jewell -

I Thomas W. Jewell considering the uncertainty of this mortal life, and being of sound mind and memory (I trust be ably God for the same) do make and publish this my last will and testament in manner and form following (that is to say)

First - I give and bequeath unto my eldest son Commodore W. Jewell, my house and lot in the town of Salem, Boone County Virginia my

Elm Street.

I give and bequeath to my daughter Arista Walton my house and lot in the town of Salem, Roanoke County, Virginia on Roanoke Street.

I have heretofore deeded to my son Flernoy a certain boundary of land for his part, lines and bounds described in the deed. I give and bequeath to my youngest daughter Edy O. Shaney Sisson the remainder of my home tract of land that I have not deeded to my son Flernoy, supposed to be seventy acres and also fifty dollars in money.

I give and bequeath to my wife Catharine, all my household and kitchen furniture during her natural life.

I give and bequeath to my daughter Louemina W. Showalter, one lot in the town of Salem, Roanoke County Virginia, on Chestnut-Street, and all money, Bonds and stock - after my debts, Burial expenses and fifty dollars in money, which I have set apart - for my daughter Edy O. Shaney Sisson is paid - and all personal property - after the death of my wife Catharine.

In witness whereof, I have hereunto set my hand and seal, the 28 day of June, in the year of our Lord one thousand - 1894,
