I, William L. Williamson, of the County of Roanoke, State of Virginia, being of sound mind and memory, do make this my last will and testament:

1. I direct that my body be decently buried in a manner corresponding with my estate and situation in life.
2. I direct that all my just debts be paid, and to that end charge my whole estate, both real and personal with the same.
3. I devise and bequeath unto my wife, Nannie B. Williamson, all my real and personal estate, of whatever nature, consisting of one lot situated on the south-east corner of Grove (or 6th) Street and 8th Avenue, S. W. in the city of Roanoke, Va.; one debt of about \$410.00 due me by Mrs. Mary C. Nelms; one debt of about \$300.00 with accrued interest, due me by Williams & Bowles

and son, J. T. Bowles, which debt is evidenced by a note of \$400.00, subject to various credits; one judgment of \$3000.00 due me by C. Lubins and Lucy C. Lubins; all farming implements and utensils; all live stock, house hold and kitchen furniture; all accounts, choses in action, and all real and personal property of whatever nature, which I now own or which I may hereafter acquire.

I hereby nominate and appoint my said wife, Nannie C. Williamson to be executrix of this my last will and testament, and request that no security be required of her.

4. I direct that my said Executrix shall release the said C. T. Lubins and Lucy C. Lubins from the payment of all of said judgment against them in my favor in excess of \$1500.00 and that she, my said Executrix, should she, in her discretion, see proper, shall require the said C. T. Lubins and Lucy C. Lubins to pay only the interest on said sum of \$1500.00 until my youngest child becomes of age, or until my said Executrix shall see proper to collect said amount, in her discretion.

5. I direct that my said Executrix collect as speedily as possible all other debts due me and apply the proceeds thereof to the payment of whatever debts may be due by me.
