she lives. I will also bequeath Mrs Bowman
for to pay my son Peter Bowman two hun-
dred dollars and my son John Bowman three
hundred dollars and my son Samuel Bow-
man two hundred dollars. my daughter
Mary Ginn and Peggy Wiseman I allow
dollar each of them having got their part
before I will and allow my daughter Mary

Spennell forty dollars I will and allow my
daughter batty Lensi bough forty dollars - I
will and allow my daughter Eve Blinc forty
dollars I will and allow my daughter Sally
Bowman two cows and two sheep when she
leave the family and forty dollars I will and
allow my daughter Mary Bowman two cows
and two sheep when she leaves the family and
forty dollars I will and allow my daughter
Susana Bowman two cows and two sheep when
she leaves the family and ninety dollars I will
and allow my son William Bowman for to pay

all the legacies above mentioned at one hundred
dollars per year the first payment for to be
made an one year after my wifes Mary Bow-
mans death and for to be paid in the same
order the are mentioned in the Will my
daughters Sally Mary & ~~Lea~~ Susanna not for to
receive the the money left to them to the
come in rotation in the Will). lastly I appoint
my wife Mary Bowman, ^{Exectrix} and my son Wil-
liam Bowman Executor of thou my last
will and Testament and I hereby revoke all
former Wills and Testaments made and

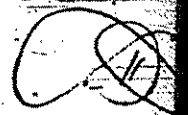
