such worldly goods as it hath pleased God  
to bless me with in this life I give devise and  
dispose in manner as follows - - - - -  
Please it is my will and I Order that all my  
just debts be Paid by I give to my dear &  
loving wife the use two Rooms in the house  
where I now live with one third of my other  
buildings and  $\frac{1}{8}$  of the land on this place or  
otherwise if she chooses to live on the land my  
brother and to have all that house with one  
third of my other buildings on the place  
where she makes her choice with the one third

at the Discretion of my well beloved wife & Daat, hereafter mentioned: and as touching such Worlsey goods as th hath pleased god to bless me with in this life I give devise and dispose in Manner as follows - - -

Item it is my will and I Order that all my just debts be Paid & by I give to my dear & loving wife the use two Rooms in the house where I now live with one third of my other buildings and  $\frac{1}{3}$  of the land on this place or otherwise if she chooses to live on the Land my father and to have all that house with one third of my other buildings on the place where she makes her choice with the one third of the land of said place so as not to have more than one third of one and my Son shall Possess the other Plantation not to be sturke by any claims of his mother but it my will that he pay to the brother that comes by his mother the one half of said place yearly and be it knowne my negro man Peter for him on the Plantation

Witnessed by my two Sons I have  
will that my negro named Romeo shall  
to have understand from what I have made  
Life and at last will be freed from his  
service if any to be disposed of by my  
Daughters Elizabeth and Sarah I further will and desire to  
She should have One horse beast two Cows  
Five Sheep the choice of my Stock with  
further beads and furniture the One half  
of my house and Kitchen for nowise If  
I give to my Son Thomas more all the  
lands that I hold of my father's Estate  
the following Slaves to Harry & Tom  
If late mill's Child to lands and slave  
him the said Thomas May his heirs  
Affixes forever with one horse which he  
now has one headstead bed and furniture  
Item I give to my Son Reuben all the  
Plantations which I Purchased of Sam  
Hornet with the following Slaves in  
left of his life

I doth also have One horse beast the  
Same I keep the Choice of my Stock with  
fourteen heads and furnishing the One  
of my house and kitchen for material  
I give to my Son Thomas moe all the  
lands that I hold of my father's Estate  
the following Slaves doe stay & serve  
of each mill's Child to lands and slaves  
him the said Thomas Moe his heirs  
Assigns forever with one horses which I  
now has one beasted bed and fire place  
Item I give to my Son Rubin all the  
Plantations which I Purchased of Dan  
Harriet with the following Slaves in  
her two Sons service George and  
Should have any increase after the death  
of this wife to be his Likewise which  
and slaves to belong to the said Dan  
Moe his heirs and assigns for ever  
which lands and slaves to be  
by any two slaves of his and Rubin  
no man living after the Plantation  
of Daniel from us fully paid

in accordance of my fathers will and desier that my  
daughter Elizabeth Walton late Elizabeth Moor  
should have the negro named named Nance  
and her child Pleas with their increase to  
her and her heirs and assigns forever with  
the Stock and furniture she has Rec'd but  
if the negroes now given to my daughter  
Elizabeth should be taken from her by  
any means through the Settlement of my  
fathers Estate she shall Recieve recare  
One hundred Pounds from my two Sons

feather beds and furniture Item I give  
my daughter Sarah the negro girl named  
Anah with her increase to her her hairs  
and assigns forever and One good mare  
one Cow six Sheep Out of my Stock at  
Other place with two feather beds &  
furniture Item it is farther my will and  
so Order that all Stocks farmar utensials  
or house furniture my Wagons and team  
the Outchells Remaining are not here  
and Dispos'd off be kept together on my  
estates by my two Sons to exp're  
what they chapp'real Payments
