& whipsaw one folding table one bed & furniture to him & his heirs forever.

Item I give & bequeath to my Son Benjamin Ten Pounds Virginia money one Iron pot to
him and his heirs forever.

Item I give & bequeath to my daughter Phoebe a bed & furniture & two ewe & lambs
to her & her heirs forever.

Item I give and bequeath to my daughter Winfred a Bed & furniture & one ewe &
Lamb to her and her heirs forever.

Item I give and bequeath to my Daughter Elizabeth a bed & furniture one ewe
& lamb & one flax wheel to her and her heirs forever.

Item I desire all the residu & remainder of my estate to be equally divided
between John & Henry & my three Daughters Except one Cabinet to my Son
