 bequeath to Pezilla Rinnibrew and her Heirs for ever
 I give and bequeath to Shadrach Rinnibrew one Negro Girl called China
 to the said Shadrach and his heirs for ever.

Item, Lastly I do appoint my well beloved Friend John Barrow and my loving
 Brother Shadrach Rinnibrew Executors of this my last Will and Testament
 disannulling all other Wills by me heretofore made and do Acknowledge
 and declare this to be my last Will and Testament in full witness whereof I have
 hereunto set my hand and seal this 4th day of Nov^r 1780
