also I give unto my Sd Daughter Ann part of a Tract or parcel
of Land bounded as followeth beginning at a white Oak in
Jose Browns line thence by a line of Market Trees to a
Yew on the South side of the Doctors Branch so down

the said Branch to a gum a corner Tree of my Land thence
by a line of Markit Tree to a Turkey Oak a corner Tree of
Jepc Browns Land thence by the sd Browns Lines to the
Beginning to hold to my sd Daughter Ann and to her
Heirs Lawfully begotten of her Body forever
also I give to my Loving Wife the third part of my
Plantation during her Natural Life and all the best and
Residue of my Lands Tenements & Hereditaments I give & devise
unto my son Josias West and to the Heirs of his Body lawfully
begotten and for what of such Issue I give the sd Lands
Tenements & Hereditaments to my Daughter Mary West
to hold to my sd Daughter Mary and to her Heirs Lawfully
begotten of her Body forever
also I give unto my Daughter Mary two Cowes & calves also
I give unto my Daughter Mary one Bed & Furniture

and all the Remainder of my Personal Estate undisposed of
by this my Will I give to be Equally divided between my said
Wife and Daughter Mary and Son Josias and I do hereby constitute
and appoint my Wife Anne and Son Josias Executors of this
my last Will and I Appoint James Jordan Scott Richard
Vick Jacob Vick and Robert Puchs to Appraise my Estate in
Witness whereof I have the sd Joseph West have hereunto set
my Hand and Seal this 7th of the 9th month.
