perfect sense & memory do make this writing my last will &
testament in form & manner as follows to wit
I Give & bequeath to my son Wm. Green the plantation he now
lives & one other tract of land joining the other on the west side
of Buckhorn swamp fifty pounds cash to him I his
heir for ever

I Give & bequeath to my son Benjamin Turner two negroes Saml & Bage
 & fifty five pounds cash to them & their heirs forever

Imp^o I Give & bequeath to my daughter Hannah Turner two negroes Tony
 & Bay to her & her heirs & fifty pounds cash & six head of cattle & her
 bed & furniture to her & their heirs forever

Imp^o I Give and bequeath to my daughter Edith Barron two negroes
 Ned & Lucy & fifty pounds cash to her & her heirs & two head of cattle
 to her & their heirs forever

Imp^o I Give & bequeath to my daughter Mary Turner two negroes Jack & Lenny
 & fifty five pounds cash to her & her heirs & one bed & furniture &
 six head of cattle to her & her heirs forever

Imp^o I Give & bequeath to my son Thomas Turner five negroes Ned Lucy
 Violet George & Phillis to him & their heirs & the plantation I now
 live & another tract of land lying on the head of Duckhorn
 swamp formerly belonging to Mr Pope & fifty five pounds
 cash & one bed & furniture & six head of cattle to him & his heirs
 And I do lend my two daughters Hannah Turner & Mary Turner
 an equal right with my son Thomas Turner in the house and
 plantation I now live in during their virginity

Turner Edith Barron Mary Turner & Thomas Turner And I do
appoint my two sons W^m Turner & Benjamin Turner my whole
sole execors revoking all other wills by me made & I do declare
to be my last will & Testament whereof I have hereunto set my hand
