SOUTHAMPTON COUNTY, VIRGINIA APPRENTICESHIP INDENTURES, 1827-1894

Among the loose papers stored in the Southampton County Courthouse are several bundles of apprenticeship indentures which give the ages, and in some cases the exact birth dates, of the children bound out. By far the greater number of these indentures (not included here) were for "free children of color", who are so indicated in the instrument, but it is of course possible that some such were not so described. A few children were apprenticed by a parent, but the majority, who were "poor children", orphans, or illegitimate, were bound out by the Overseers of the Poor, to relieve the county of financial responsibility for their care. Some twenty of these indentures were checked through the grantor and grantee indices without being found; but whether or not they are recorded is of little moment, as the index would show only the grantor and grantee, and not the names of the children.

The terms of apprenticeship were the conventional ones, boys to serve until 21, girls until 15. The girls were to be taught housewifery; most of the boys were to be taught husbandry, although a few trades are mentioned. A minimum education was called for, and the usual clothing, tools, stock, or cash to be given at the expiration of

service.

When the name of a parent is shown in the indenture, it is included in the following list. The date of the court order to bind out the child, when shown in the indenture, is also included; reference to the appropriate Order Book may reveal the name of at least one parent and the reason for the apprenticeship. Since these indentures generally followed closely upon the date of the court order, it is possible that records of the immediately previous courts may contain family data of help to the searcher, even when the date of the court order is not shown.
