

In the name of Goddmen I George Fraser of Spotsylvania County and Parish of St George being in Perfect Health mind & memory (praise be God) Do make this my last Will & Testament, as followeth. I Give unto my lawfull Married Wife Esther Fraser all my Reall and Personal Estate during her Widows head in case she provides for my Two Children - Mary & Sally Fraser but in case any of my Two Daughters should Marrie with their Guardian's Consent or attain to the age of Twenty one year they must have their third Part if I should be Possessed with Land in the County before my Death it must not be sold Except my third part of Two Lots in Fredericksburg N. 23 & 24 and that to be sold and that the Money arising from same to put out to Interest after my lawfull debts is paid, for the of my Two Daughters but the Land that may be in my Possession to be Valued by my Executors of my Eldest Daughter Mary to pay the other the one half of the Valuation, in case my wife Marries again then my Two first Executors shall take all my Estate out of her hands leaving her one third during life and that third to Equally Divided betwixt Mary and Sally Fraser my Negroes to be kept together till one of my Daughters Marries with Consent of her Guardian or the age of Twenty one and then Divided, W. James Hunter and W. Andrew Shepher and my wife Esther Fraser my voll Executors

If it should Please god to bless me with a son in Marriage with Esther Fraser, in that case then none of what Land I may be Possessed with at my Death, ^{be sold} but Obtain his Property of one Equall part of all my Reall and Personal Estate Except the Value of one third part of all my Lands bought by me after this date to be Valued by my Executors & Equally Divided amongst the Daughters above Mentioned, in case on should die to revert to the son if any, in Default of such the Daughters but if it in Gods Will that all should die, in that case my Sister in Scotland - Mardunhere to be Joint Heirs Joabell, Jean & Margret Fraser and there heirs for ever, Except what Negroes my Wife had at Marriage and them to be at her Disposall with their Increase in case of our Children. by me Signed Sealed this 28 June 1768

Justices of Spotsylvania Court Court now sitting in the sum of Five Thousand Pounds To the Payment whereof well and truly to be made, to the said Justices and their Successors, we bind our selves, and each of us our and each of our heirs, Executors and Administrators, jointly and severally firmly by these Presents sealed with our seals this 2. Day of April in the year of our Lord one thousand seven hundred and sixty five and in the fifth year of the Reign of our Sovereign Lord George the third

The Condition of this obligation is such that if the above bound Esther Traver Executor of the last Will & Testament of George Traver Deceased do make or cause to be made ~~and~~ ^{and} Perfect Inventory of all and singular the Goods Chattels, and Credits of the said Deceased, which have or shall come to the Hands Possession or Knowledge of her the said Esther Traver or her Person or Persons for her or into the hand or Possession of any other Person or Persons for her, and the same so made do Exhibit or cause to be Exhibited into the County Court of Spotsylvania at such time as they shall be there required by the said Court and the said Goods Chattels & Credits and all other the Goods Chattels and Credits of the said Deceased at the time of his Death which at any after shall come to the hands Possession of the said Esther Traver or into the hands or Possession of any other Person or Persons for her so well and truly administer according to Law and further do make a just and true account of her doings & things there in, when there is required by the said Court, and also so well and truly pay and deliver all the Legacies Contained and specified in the said Testament as far as the Goods & Chattels and Credits will thereunto extend according to the Value thereof and as the Law shall Charge her Then this Obligation to be void otherwise to remain in full force and Virtue
