this my last will and Testament in manner following

- I give and bequeath unto my Daughter Mary Jones two female negroes the one
named Jenny the other Lucy unto my said Daughter and her heirs and assigns forever.
- I give and bequeath unto my Grandson John Taliaferro Lewis a negro boy named Moses
to him and his heirs and assigns forever.
- I give and bequeath unto my Grandson Charles Augustus Lewis and to his heirs
and assigns forever a Sallow called Scott also Billy
- I give and bequeath unto my Grand Daughter Mary Warner Lewis and to her heirs
and assigns forever two negro girls named Ester and Polly
- Item It is my desire that each of my Daughters in their husbands pay annually unto my
eldest Son for and during the term of her life the sum thirty shillings a piece
- Item All the rest and remainders of my Estate of what nature kind or Quality soever I give
unto my Daughter Lucy Lewis and Mary Jones to be Equally Divided Between them
share and share alike and touching such Slaves as shall fall to either of them under

by virtue of this disposition as well as the slaves herein before specifically bequeathed, It is my will that the same be to my Daughters and their present husbands during their lives and the life of the longest liver of them (that is to say) such of the Slaves as shall in a division of my Estate be the part of my Daughter Lucy Lewis as well as those given to my Grandchildren be to my said Daughter Lucy Lewis and her husband Mr Charles Lewis during their lives and the life of the longest liver of them and upon and after their decease the said Slaves the part of my Daughter Lucy Lewis. I give and bequeath unto my Granddaughter Mary Anne Lewis and her heirs and assigns forever and the other two Moses and Betty also shall as herein before directed and touching such part or the division of my Estate as shall be the dolt of my said Daughter Mary Anne Lewis the said Slaves as well as those herein before specifically given to her and my said Daughter and her present husband Mr Joseph Lewis during their natural lives and the life of the longest liver of them and after their decease unto such Child or Children of my said Daughter as she shall leave living at the time of her death and their heirs and assigns forever and on failure of such Child or Children then to be amongst such Child or Children of my said Daughter Lucy Lewis as my said Daughter Mary Anne shall by any writing under hand direct and appoint and in default of such appointment then to be equally divided between the Children of my said Daughter Lucy Lewis share and share alike, And of this my will I appoint my son-in-law Charles Lewis and Joseph Lewis Executors hereby revoking all former wills by me made declaring this only as and for my last will and Testament In Witness whereof I have hereunto set my hand and seal this Day of January 1778
