Andros Kn^t their Ma^{ty} Lieut^t and Gov^r Gen^l of Virg^a send
greeting, Know ye that by Virtue of their Ma^{ty} Commission
to me directed I do hereby Commissionate Authorize and
Appoint you Henry Tucker Gent^l to be high Sheriffe of
Surry County for this present years one thousand six
hundred and ninety four, and that you be accordingly
sworn as soon as conveniently can be, and before you
be admitted to the Office of Sheriffe of the said County of Surry
you enter into bond before their Ma^{ty} Justices of the Peace of the
said County with good and sufficient Security in the penal
sum of one hundred thousand pounds of tob^o to our Lord
reigne Lord Jany the King and Successors their heirs and
Successors to render unto us Audit^r Byn or such others as
shall be appointed to receive the same a strict and full
account of all their Ma^{ty} Revenues and dues in the
said County during the time of yo^r Sherifalty, and
also that you shall due payment make of all such publick
dues as shall be levied in the aforesaid County of Surry
