thousnd of 1000, & one more to Rob^t Briggs, & & he did also owe
Doll^{ars} to J^{rs} Emerson & Christopher Foster, & & they did owe
him Doll^{ars} likewise, but he would send for them in & Morning
& settle & buy himself: for he doubted & if it were not
done by himself before he died there would be some wrangling, & he
did this desire was in Francis Hlogwood should take all & he had
in Virginia & pay all his Just Debt, & it would remain when
his Debt were paid he should take to himself for his own
proper use. & & Next morning J^{rs} Emerson & Christ Foster
was sent for but before they came & d. Tho: Wall died. Witness
