Goods which it hath Pleas'd God to bestow in manner following -

First I give unto my Loving Wife all my worldly goods & Estate Except one thing his first and first fool my mare shall bring -

(2) I give my son in Law Robt. Hummcut one thing his first fool mare or horse of my mare brings & his first fool withall her increase -

(3) I do make my Loving wife my whole & sole Exor. of this my Last will & Testament to see and pay all my lawfull & just debts & I do appoint

John Hummcut and Robt. Craford to be overseers of this my Last will & Testament to see it fully & truly fulfilled as witness my hand & seal 7 day years first above written
