My Body I desire may be Buried in a Christian like manner According to the Discretion of my Executors hereafter mentioned, and as touching that Worldly Goods it hath pleased Almighty God to bestow upon me, them (after my just Debts for funeral Charges are paid) I dispose of in manner, & to the Persons following.
