- Executors whom I shall here after Appoint. and as touching what Temporal beatare it hath pleased Almighty God to blese me with, I give and Dispose of the same as followeth.
- Item I give & bequeath unto my son Joseph Carter my Large oval Table.
- Item I give and bequeath unto my son Richard Carter the Mansion house where we now live with all my lands in Prince George & Sussex Counties. also my Negros Man Henry and my Negros wench Agg also all my hogs and four Cows & Calves and one feather Bed and furniture and all my Carpenters Joiners & Coopers Tools and Hacking blades and a whip saw and Crisp but saw to him and his heirs for ever also one dark and one small oval table.
- Item I give & bequeath unto my Daughter Mary Carter three Negros viz Lucy Ned and Bob and one feather Bed & furniture and one Chest & one spinning wheel and my large Crisp Kettle to her and her heirs for ever, also my Loom and all my Hacking gear.
- Item I give & bequeath to my Daughter Elizabeth Hall one Negro Girl named Liddy & Fifty pounds Current money of Virginia to her and her heirs for ever.
- Item I give and bequeath to my Daughter Anne Thwa her Negros during her Natural life named Emmy & Laura and after her decease to her daughter Lucy & her heirs for ever.
- Item I give and bequeath to my Daughter Ann Carter two Negros named George & Sam, one feather Bed and furniture one Chest to her and her heirs for ever.
- Item I give and bequeath to my Daughter Lowrey Carter two Negros named Dick and James one feather Bed and furniture one Chest to her & her heirs for ever.
- Item I give and bequeath to my Daughter Rebecca Carter three Negros named Cyrus, Patsy & Eliza to her & her heirs for ever.
- Item I give and bequeath to my Daughter Rachel Carter three Negros named Toney, Tuesday & Rowell and five pounds Current money to her & her heirs for ever.
- Item I give and bequeath to my Grand son John Simmons & fifty pounds Current money of Virginia with this Provision, that is to say, I desire my son Richard Carter may have the Use of the above & fifty pounds until he the said Simmons comes of Lawful age, also that he shall live with the said Carter or some Person that has the said Carter shall approve of until he comes of Age, and if he refuse to do it is my will that he the said John Simmons
