In the name of God Amen I Sarah Moore of Sussex County and Parish of Abbeville being Sick & weak, but of perfect mind and Memory, Thanks be to God for the same I do constitute & appoint this my last Will and Testament in manner & form following First I Give my Soul to Almighty God that Good me, and my body to the Earth to be buried at the discretion of my Executors, and as to my worldly affairs I Give & dispose of the same in manner following.

I Give & bequeath to my Son John Sands ten Pounds current money to him & his Heirs forever.

I Give & bequeath to my Son Samuel Sands five shillings current money to him & his Heirs forever.

I Give & bequeath to my Daughter Martha Moore two Negro Boys namely Joe & Sam to her & her Heirs forever.

I Give & bequeath to my Daughter Rebecca Moore two Negroes namely Abby & Jane to her & her Heirs forever.

I Give & bequeath to my Daughter Sarah Moore two Negroes namely Abraham & Sydaal to her & her Heirs forever.

I leave thirty Pounds current Money in the hands of my Executors hereafter named during the natural life of my son Samuel Sands, and the Interest of the same to be laid out in the maintenance of his Children according to the direction of my Executors, and after my said son's death I give the said thirty Pounds current Money to my Grand son Barham Sands son of Samuel Sands to him & his Heirs forever.

My Will & desire is, that my Land Stocks & Household furniture of all kinds be sold at Public Sale and the Money arising thereby as well as the debt due to me and the whole remainder of my Estate after my Debts & Legacies are paid, be equally divided between my three Daughters Namely Martha Sarah & Rebecca Moore.

I do appoint my son John Sands & my Daughter Martha Moore my Executors and Executrix of this my last Will & Testament, ratifying & confirming this and no other to be my last Will & Testament, Lest my Will is that there be no Appraisement of my Estate in Writing whereby I have hereunto set my hand & Affixed my seal this twenty fifth day of September in the Year of our Lord one thousand seven hundred & seventy one.
