year of our lord One thousand seven hundred and seventy six, Nathan Northington
of the county of Sussex and Parish of Albemarle being of sound & disposing mind
and memory thanks be to Almighty God for the same and calling to mind
the certainty of death and uncertainty of this transitory life do constitute
and ordain this my last Will and testament in manner following, that is to say,
first and principally I recommend my soul into the hands of Almighty God, who
gave it me, hoping for salvation through the Merits and Mediation of my blessed
Redeemer (Jesus Christ). And as for my body, I commend it to the earth to be
decently buried at the discretion of my Executors hereafter named and as for my
worldly goods wherewith the Almighty hath been pleased to bestow upon me
I give and bequeath as follows.

Impious Give and bequeath unto my loving son Jacob Northington and to his heirs and
Assigns my negro boy, Will, which ^{he} has now in possession; also two Doves and
Larrels.

Also.. Give and bequeath unto my loving son Nathan Northington and to his heirs and
Assigns my Land and plantation wheron now live on the north side of the great
swamp containing two hundred and fifteen Acres, be the same more or less, and
to be given up to him immediately after my decease. Also give my said son Nathan
my negro boy Stephen.

Also.. Give and bequeath unto my loving son John Northington and to his heirs Assigns
the lower part of my tract of land on the southside of the great swamp, containing
by estimation two hundred and twenty five acres be it more or less being the
land purchased of Gilbert Keys part of Thomas Griffis and part of David Mason,
for which Richard Key made me a deed for, and the said land is bounded
as follows Beginning at the Mouth of a small branch on the south side of the
great swamp next above the plantation purchased of the said Thomas Griffis
and is called Griffis's branch, at a small white oak made a corner, Thence up the
said branch to the fork thereof, Thence up the west or upper prong of the said branch
to the head thereof to a small live oak, Thence along a line of marked trees dividing
this land from the land lately purchased of my son Jacob to Odams branch to a

Also It is my Will and desire that all the rest and residue of my estate not heretofore devised be sold to the highest Bidders on a reasonable credit and the money arising by such sale (after paying all expences attending) the execution of my Will and Reserving the legacy devised to George Rigbee and others) be equally divided between my seven children Namely Nathan, John, James, Samuel, Elejah Sarah and Anna or the survivors of them and in case either of them should dye before such division and shall have lawfull issue then such Issue to share the part that would have fallen to parent of said issue

And Lastly I do hereby nominate, constitute and appoint my loving son Nathan Northington and my friend Daniel Fisher my Executors of this my last Will and testament, hereby revoking all former Wills and bequests by me heretofore made and allowing this and no other to be my last Will and testament.
